

We are pleased to share the latest accomplishments from Tech4Gov in the month of April, marking the beginning of the new financial year! The unwavering dedication of our team has led to the successful completion of deliveries, further solidifying our relationships with government stakeholders and partners.

Milestones – April'2024

1. On April 18, 2024, PIRAMAL Swasthya, Astrika Foundation, and the Bihar Nursing Reform Council signed a significant Memorandum of Understanding. This tri-party agreement represents a strategic collaboration to drive reforms and innovation in the nursing sector
2. The Project Closure letter has been successfully submitted to ICDS. This marks the first time we've applied the Build-Operate-Transfer (BOT) model and a Capacity Building approach, empowering the government to independently advance its IT.
3. While the State Health Society, Bihar (SHSB), is in the process of procuring an attendance application subscription, we are providing interim support through Darpan Plus to monitor doctor attendance across 12 districts in Bihar
4. As part of the BNRC reforms project, we've launched and rolled out the innovative Ni Tag App across Bihar, creating a comprehensive map of nursing institutes.

Highlights – April'2024

In addition to the aforementioned milestones, the Tech4Gov team has conscientiously dedicated efforts to address the following tasks:

1. Coordinated with the Facility Certification Product Team and provided orientation to 10 Community Health Officers on application access for the NQAS checklist assessment. This step ensures seamless quality assessments and adherence to healthcare standards.
2. Collaborated with the CDT Team to design a diagnostic framework for Public Grievance Redressal System. This learning experience will be instrumental in deploying similar frameworks in other states.
3. After collecting requirements for streamlining employee salary calculation with Sh. Omkar Ji, State Finance Manager at SHSB, we have submitted the Functional Requirements Specification (FRS) document for approval.
4. Prepared by prior research, which will engage stakeholders for BNRC's Digitizing

Bihar Nursing Registration Council, ensuring alignment with needs and driving success. This approach targets 20% time savings, benefiting ANM & GNM Colleges and Administration.

5. Provided expert guidance to the tech team at PSL Big Bet to address and resolve all vulnerabilities identified during the security audit of the web portal <https://rwpf.in/>, ensuring a comprehensive approach to security and compliance.
6. Developed and delivered the DWR Dashboard, a powerful tool for monitoring district-level weekly meetings. This dashboard provides insights into meeting frequency, leadership, and attendance, as well as tracking the number of issues raised and unresolved. With this information, stakeholders can make informed decisions and address concerns more effectively.
7. Trained DPC and assessors on using the SukrTya App for assessing HSC and APHC facilities. Additionally, we developed specialized facility assessment tools on the SukrTya App for these assessments.
8. Developed and delivered the DWR Dashboard, a powerful tool for monitoring district-level weekly meetings. This dashboard provides insights into meeting frequency, leadership, and attendance, as well as tracking the number of issues raised and unresolved. With this information, stakeholders can make informed decisions and address concerns more effectively.
9. Work on Business Requirements Documentation (BRD) for Pragati 2.0 has begun, and the agenda for Workshop III, scheduled for the 13th and 14th of May, has been finalized.
10. **Mr. Mayank** has visited Health Department, Lucknow to meet with DA-DGMH, and gained insights into the current litigation management system practiced at DGMH, DGFW and DG Trainings.
