Services:

- 1. IAS Sanjay Singh (ED, SHSB) and Dr. A.K.Shahi (SPO, HWC cell) commended the well-organized arrangement of the Dashboard in **Sukrtya**, particularly for incorporating their historical assessment data.
- 2. Training Conducted for DM&E officers and Districts Coordinators for **Baal Hridya Yojna** Backlog Entries, then Entries are being started by the respective districts. As of now, a total of 805 entries have been recorded across the state.

Products:

 A training session was conducted for State Officials of ICDS on BADI app prior to the pilot implementation in various districts. This aimed to equip them with the necessary skills to support lady supervisors in seamlessly accessing the application and establishing one-down master trainers.
