2. Following the successful User Acceptance Testing (UAT) of the in-house developed ICDS app, BADI (Bihar Aanganwadi Detail Information), the Director of ICDS has officially released the letter for field testing.

1. After the successful testing of the Supportive Supervision portal at Sitamarhi DH, we have initiated field testing at Araria District Hospital.

In addition to the mentioned milestones, the Tech4Gov team had also diligently worked on the following items:

1. Our team has commenced the process of comprehending the Supply Chain Management (SCM) process in collaboration with the PMU Team of BMSICL. We

- are actively engaged in contributing to the design of the work plan for this program.
2. The State team has provided orientation to the District RBSK Team, and in collaboration with our team, a plan has been devised to implement the new portal statewide. This plan specifically addresses the entry of old records by districts.
3. **Mr. Manish** provided exclusive support to the Assam team in restarting the portal and its associated services following the server relocation. Additionally, Ms. Nitika conducted thorough testing of the PGR portal which will help us to conduct an upcoming online training program.
4. Our team has initiated efforts on the Nursing Reforming Program and has provided support for the following activities:
 - a. RFP Finalization with a focus on defining the required skills set for technical resources.
 - b. Initiated collaboration with Aastrika Foundation to execute the implementation of the **e-Kshamata** application. This application is specifically designed for the skill-building and competency assessment of healthcare personnel, with a special emphasis on nurses and nursing students etc.
5. **Mr. Sourav** has actively collaborated on the **Sukritya** app, addressing and resolving bugs. The app is utilized for conducting surveys on HR and infrastructural details of Health and Wellness Centers (HWCs) throughout the state.
6. After extensive support in Teacher Transfer portal, **Mr. Chandan** has also played a very crucial role in development of BADI App. Despite taking leaves or holidays, he consistently made himself available to contribute to the delivery of this product.
